Investment Objective

The Fund seeks to offer broad, low cost exposure to international stocks of companies in the developed markets in Europe, Australasia and Far East, excluding the United States and Canada.

Investment Strategy

The Fund employs an indexing investment approach designed to track the performance of the MSCI EAFE Index, a widely recognized benchmark of international developed stock market performance that is made up of stocks of companies in developed markets in Europe, Australasia and Far East, excluding the United States and Canada. The investment manager attempts to replicate the target index by investing all, or substantially all, of its assets in the stocks that make up the index, holding each stock in approximately the same proportion as its weighting in the index. In some cases, it may not be possible or practicable to purchase all of the securities comprising the Index, or to hold them in the same weighting as they represent in the Index. In those circumstances, the Fund may employ a sampling or optimization technique to construct the portfolio.
